Started actual demand settlement of HUOBI Group's proprietary crypto asset HT (Huobi Token)

On October 4, 2021, Huobi Japan Inc. (President and CEO: Haiteng Chen" (hereinafter referred to as "Huobi Japan") began to pay actual demand for Huobi tokens (HT), the Huobi group's proprietary crypto assets.

As part of the "Digital Asset Financial Services" built by Huobi Japan, we will start providing actual demand payment services with crypto assets for a limited time, verifying the efficiency and speed of settlement operations.

Specifically, it is possible to receive services provided in physical stores using HT, a decentralized proprietary crypto asset on the Ethereum blockchain issued by Huobi Global, a group company of Huobi Japan.

1. Background to the start of actual demand settlement

Price fluctuations, which are also one of the appeals of crypto assets, have become a barrier to exchange with designated fiat currencies.

Therefore, this time, we decided to introduce actual demand settlement on a trial by partially changing the service in response to price fluctuations.

For settlement, we will provide services in response to price fluctuations using HT, a decentralized proprietary crypto asset on the Ethereum blockchain, issued by Huobi Global, a group company of Huobi Japan.

2. Details of actual demand settlement

- Currency that supports settlement
 HT (Available at Huobi Japan exchanges and sales offices.)
- Details of actual demand payment service
 Customers who own HT can pay for eligible courses with HT at Roppongi Yakiniku MASU,
 which has stores in Roppongi. The content of the course will be determined by the price of
 HT on the day and will be provided to the customer.
